Following an Investigation commenced on the **Tenth February 2023**;  
And an Inquest opened on the **Twenty-Third March 2023**;  
And an Inquest hearing at **Vantage House, Unit 1A Vantage Park 9 Washingley Road, Huntingdon, Cambridgeshire** on the **24 November 2025** heard before **Simon Milburn, Area Coroner**, in the coroner's area of **Cambridgeshire and Peterborough**, and the undermentioned jurors

Fallon came to her death by intoxication of mixed drugs where the illicit obtaining of diazepam had a high probability of causing her death.

failure to conduct adequate welfare checks and observations allowed for missed opportunities to intervene. evidence of this was staff admitting not being able to confirm respiratory movement observations, observations of movement and general observations of inmate. her unsatisfactory training was also highlighted in evidence however this did not cause or minimally contribute to Fallon's death.

fallon came to her death between 18:33 on the 8/12/23 and 7am on the 9/12/23.
